PSI Preparations towards the United Nations High Level Dialogue on Migration and Development (HLD) and the parallel event on the Peoples' Global Action on Migration,

Development and Human Rights (PGA)

30 September – 4 October 2013, New York

This is in follow up to PSI Circular Gen. No. 5 dated 25 April 2013 regarding the UN High Level Dialogue on Migration and Development.

In a time of economic crisis and continuous assault on public services and on workers' rights everywhere, PSI is building forces within the trade union movement and with civil society coalitions in defending the human and trade union rights of migrant workers. Only when we are able to defend all workers, fight racism and discrimination, promote equality, access to justice and quality public services for all, can we truly make the trade union movement strong.

Together with the Global Union Federations and allied civil society organizations, we have put together a line-up of activities that will bring our voice, our union power and our force in bringing workers' rights at the global dialogue on migration and development.

1. Inside Events at the UN High Level Dialogue on Migration and Development (3-4 October 2013)

As per UN General Assembly Resolution 67/219, the second High Level Dialogue on International Migration and Development (HLD) will convene at the UN Headquarters in New York on 3-4 October 2013. The HLD will consist of four plenary meetings and four inter-active multi-stakeholder round tables. The themes of the round tables will be:

- Assessing the effects of international migration on sustainable development and identifying relevant priorities in view of the preparation of the post-2015 development framework;
- Measures to ensure respect for and protection of the human rights of all migrants, with particular reference to women and children, as well as to prevent and combat the smuggling of migrants and trafficking in persons and to ensure orderly, regular and safe migration;
- Strengthening partnerships and cooperation on international migration, mechanisms to effectively integrate migration into development policies and promoting coherence at all levels;
- International and regional labour mobility and its impact on development.

Civil society representatives accredited to the HLD will participate and observe in the plenary meetings and roundtables. The trade union delegation is working with other civil society organisations in forwarding our list of speakers to these plenary and round table meetings. Our ultimate aim in our participation to the HLD is to bring the global dialogue on migration and development back into the rights-based normative framework of the United Nations, and placing the issue of labour migration within the competence of the International Labour Organisation.

Moreover, the Global Unions will hold a preparatory panel event on 2nd October: "Migration and Development: A Decent Work Issue." The objective of the meeting is to bring together representatives of governments and trade unions in a dialogue to exchange information, highlight best practices and strengthen trade union-government cooperation on the gender-sensitive and rights-based approach to migration and development. The meeting will take place inside the UN building in New York. The exact time and location of the meeting will be confirmed shortly.

2. Outside Events at the Peoples' Global Action on Migration and Development (30 Sept – 4 October 2013)

The 2013 People's Global Action on Migration, Development & Human Rights (PGA) is an independent civil society and grassroots event held in conjunction with the 2013 UN High Level Dialogue on Migration & Development (HLD). Since the first HLD in 2006, the PGA has annually brought together grassroots migrant communities, migrant rights organizations, trade unions, faith groups, academia and civil society networks from around the world to share information, dialogue, strengthen analyses and develop joint positions on critical issues related to international migration. The PGA provides the space for communities to critically engage in the UN HLD process and to challenge neo-liberal economic policies that lead to forced migration and violations of migrant workers' rights. A week-long programme of activities will include:

- Labour-Community Rally and March across the Brooklyn Bridge (Wednesday, 2 October, 5pm at Foley Square)
- Workshops, strategy sessions and forums to share analysis, organising and platform for migrants rights in the US and globally (1-4 October)
- New York City site visits and exchanges with migrant community organisations
- Migrant arts and activism films, art, photography

PSI and its affiliates will be among the prime movers in the Labour-Community Rally and March at the Brooklyn Bridge. Likewise, PSI will be organising workshops at the PGA.
