







"Public Service Trade Union Action Planning Meeting on Social Protection for Migrant Workers"

A Collaboration between Public Services International and the ILO-EU Decent Work Across Borders Project Hotel Sylter Hof, Berlin, Germany 28-30 November 2013

1. Background

Social security systems are invaluable mechanisms to provide income security, reduce poverty and inequality and promote social inclusion and dignity. The territoriality nature of social security systems, designed within national boundaries and the various requirements associated with entitlements, e.g. nationality and minimum qualifying period of contributions, create particular hurdles for migrant workers seeking to avail of their rights. Weak coordination between national systems poses a challenge, as workers move across borders and enter into different national systems. Migrant workers can end up supporting the welfare system for permanent residents and citizens, while experiencing loss of wages and denial of entitled accrued benefits upon returning to their country of origin. Moreover, the increasingly dynamic nature of the global labour markets and the shift toward temporary modes of migration require that national social protection systems take steps to ensure that migrant workers are not stripped of their right to social protection.

Set against this backdrop, Public Services International (PSI), in collaboration with the International Labour Organization Decent Work Across Borders Project (ILO DWAB): a *Pilot Project for Migrant Health Professionals and Skilled Workers*, funded by the European Union, is organising a "**Public Service Trade Union Action Planning Meeting on Social Protection for Migrant Workers**," **28-30 November 2013**, **Berlin, Germany**. The meeting will build upon the background study being prepared by PSI, with funding from ILO DWAB, on the "Roles and Responsibilities of Trade Unions in Promoting Access and Portability of Social Protection Entitlements for Migrant Workers." The findings and draft recommendations of the study will be presented and examined in the meeting. The PSI Consultant leading the background study is Dr. Nicola Piper, based at the University of Sydney, Australia.

2. Objectives of the Meeting

- 1. Strengthen solidarity between public service trade unions in origin and destination countries in promoting migrant workers' rights and access to quality public services for all;
- 2. Build a common understanding among public service trade unions of the existing policy frameworks, realities and challenges in ensuring access to social protection for migrant health and social care workers; and
- 3. Formulate a three-year action plan to be undertaken by public service trade unions in Asia and Europe to ensure access to social protection for migrant health and social care workers.
